Secretary's Report for March 10, 2021 was edited and approved. MSP (Jan, Dean)

Treasurer's Report (placed on file) Highlights listed below. MSP (Kim, Laurie)

- Offering (envelopes & online offerings) for the first 3 months is \$89,570.00. This is up 11% from 2020.
- Total income for the first 3 months is \$89,570.00.
- Total expensed for the first 3 months is \$95,746. This is down .6% from 2020. \$10,000 less deficit than last year.
- Net income is \$-6,175.00.
- Checking account balance at the end of March is \$12,653.00. This has been spent on payroll and bills.
- From the Finance team, motion MSC, whenever Special Accounts receive \$500.00 in building fund, it will be transferred to Thrivent.

- The Staffing Team met with Scott Solberg on April 5th to finalize arrangements for his Temporary Choir Director contract. Scott's temporary contract was adjusted to begin compensation the second week of March when the choir resumed rehearsals and begin recording for Sunday worship services. The choir will continue to practice every week and record selections for worship services through the first Sunday in June. Scott will be reimbursed at \$100.00 per week for this temporary contract and another contract will be in place when the choir resumes practice in the fall.

- 1. Response Team updates
 - Meeting May 4. Will further discuss options as more people become vaccinated.
- 2. Diversity Task Force update
 - Five of six people who have volunteered. Pr. Elizabeth has an email out to a person to be the leader. Once this is determined, the Diversity Task Force will start meeting.
- 3. Music Task Force update
 - The Music Task Force met Tuesday, March 16th and questions were finalized for a survey of individuals currently involved in Trinity's music ministry. The survey includes questions designed to gather information on participation, planning, recruitment, and future worship options. Several members who are in the Choir, Praise Band, Handbell Choir and our accompanists will be contacted to provide their perspectives. Results of the survey will be discussed at our next meeting on April 20th.
- 4. Team Guidelines & Procedures

- 5. Security update
 - Free pantry has been moved.
 - Pr. Elizabeth shared thoughts and questions of locking and unlocking the southeast door that leads to the offices. What days? What hours? Who is responsible to lock/unlock? There is a proposal for installing a security lock. Is this the best solution? Do we post strict hours? Not sure if this best idea if folks are coming and going.
 - The staff will start on May 1 using keys to unlock and lock the southeast door. This change will be communicated via the newsletter, signs, etc.
- 6. Facilities Planning Committee update
 - Will be meeting with the architect and Wieser Brothers in the next few weeks.
- 7. Finance Team
 - Barb shared that members saw we had building fund for Easter donations, and there are
 questions from the congregation. Some members are bothered by this request as the
 building project has not been advertised.
 - There have been specific donations given for this purpose of building an addition.
 - Barb shared a concern from several members because the building fund was an option for Easter donations. Since the project has not yet been voted on by the congregation, the Finance Team feels we should wait on having it listed as a giving option.
 - Pastor Elizabeth and Saundy will make sure we do not have the building project listed as
 a giving option until there is an approved plan that the congregation has voted on and
 supported. However, we will accept any donations given for this proposed project.

- 8. Property Team
 - The ramp has been removed.
 - Grass seed will be added to the area where the ramp was.
 - Information will be submitted in the May newsletter about the removal of the ramp.

 - Jan made a motion to extend a temporary contract to Scott Solberg, Choir Director, effective March 10, 2021 to June 10, 2021, Steve seconded. MP
 - Another contract will be offered in the fall.
