#### **STAFF REPORTS:**

### **Pastor Elizabeth:**

- 1. Vacation was great! Pr. Lane also had a good vacation I believe. Having foot surgery August 6 which will limit my mobility for 6-8 weeks. I will have a scooter and crutches to get around.
- 2. I attended a Bias and Burnout class on 4 Thursdays in June for an hour or so each day (all on Zoom, naturally), through Luther Seminary's Faith + Lead program. I am taking another one in August on Generosity. I also continue my work on the Synod's Fall Theological Retreat team. I also continue to participate in Spring Grove 2030 meetings and planning.
- 3. Vacation Bible School was not well-attended, especially toward the end when only 1-2 families attended. Hopeful we won't have to do it this way ever again.
- 4. Confirmation Camp, on the other hand, was great! It was wonderful to have 30 youth overnight at the church, at GEV for a day, and here all day on two other days. And I was right: It was exhausting!
- 5. We have 3 more baptisms this weekend what a blessing!
- 6. Pr. Lane and I have also each had a funeral in the last few weeks.
- 7. Pr. Elliott Malm recently left Mabel First and Scheie for another call. They do not have an interim (and may not get one for some time). Pr. Lane is covering some pastoral visitation and, depending on how long the vacancy lasts, I may do some pastoral support as well. I plan to

- speak with Assistant to the Bishop Barb Streed to learn more about how they plan to move forward with this vacancy.
- 8. I am very excited about our plans for a weekend of "Fellowship and Renewal" September 18-19. As mentioned, we have reserved the Fest Building for our regular 5 p.m. communion worship service Saturday, followed by a big community concert at 7 p.m. The theme of the weekend is "See, I make all things new" from Revelation 21. Sunday's guest preacher will be Ret. Bishop April Larson (first female bishop in the ELCA, La Crosse Area Synod).

We'll coordinate this weekend with Rally Sunday for our youth, and hopefully a fellowship time to follow. We'll send out "Save the Date" information in a few weeks, advertise in the local papers (and on KVIK), the bulletin, the newsletter, etc. And then another postcard in early September as a reminder.

I have already talked to Pr. Len Liptack to engage Faith of Blackhammer and Garness, and today I spoke with representatives of Mabel First and Scheie. I hope also to engage Wilmington, and possibly some other local area congregations as well. The Worship team is meeting next Wednesday to continue planning worship and music.
